Janaki Branch, Durgauli Kailali.
3. Bid must be submitted to <https://bolpatra.gov.np/egp/> before 12.00 hours on 31st day from the date of publication.
4. Bids shall be opened in the presence of Bidders' representatives, who choose to attend at 2:00 PM on 31th day of Notice Published. Bids must be valid for a period of **90 days** counting from the day of bid opening.
5. Bid shall be accompanied by a bid security of an amount as shown in the above table. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in the following address or a bid bond issued by a bank approved by Nepal Rastra Bank valid beyond a month from bid validity period and submit the original receipt of the deposited amount of cash along with the bid.

6. After acceptance of bid, the Performance bond 5% of the quoted bid amount should be authorized from recognized commercial bank of Nepal, which shall be valid beyond a month from the defect liability period of the works.
7. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
8. Janaki Rural Municipality office will not be responsible for any costs or expense incurred by bidders for preparation or delivery of Bids. Except the mentioned clauses all other conditions of the bidding process must be followed the public Procurement act 2063, Public procurement regulation 2064.
9. In the case of discrepancies or error in bid documents, bid notice or any other documents, Janaki Rural Municipality reserves the right to amend and correct at any time. The figure for the bid amount must be clear if any discrepancy may occur then the figure written in word is valid.
