1. **Janaki Rural Municipality has allocated funds towards the cost of Upgrading of Pahadipur – Fireline Road** and intends to apply part of the funds to cover eligible payments under the Contract for Contract Identification No: 01/JRM/1S2E/W/2079/080. Bidding is open to all eligible as per Section V of bidding document.
2. **Janaki Rural Municipality invites electronic bids from eligible bidders for the construction of Upgrading of Pahadipur – Fireline Road under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.**

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years : **NRs. 4,68,00,000.00**
  - Minimum Work experience of similar size and nature: **One Number Of project having NRs.1,25,00,000.00**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.


